Foundation's Non-Profit Feature: Stepping Stones

Stepping Stones is a local non-profit organization that provides food, shelter and support to those in need in Dunn County. Stepping Stones distributed as well as fresh or seeks to foster a community that prevents hunger, homelessness and isolation through three primary programs: a food pantry, homeless shelters and the Community Caregivers Programs.

The food pantry provides food and personal care items to low income residents. Canned and packaged non-perishables are frozen food such as bread, dairy, produce and meat. The pantry averages over 1,400 visits per month and also supplies schools and Head Start with food for children and youth at risk of hunger on the weekends.

The Shelter Program currently has two shelter locations: 1920 S. Broadway and 1518 Stout Road. Combined, these two shelters have 5 furnished apartments for individuals or families. Residents work closely with shelter staff to secure affordable housing, to find or maintain employment and to access resources to become self-sufficient.
